

NOTICE TO BIDDERS: Bids must be submitted on this form. Bids made otherwise will be subject to rejection. All taxes and shipping on any item that the City may be required to pay must be shown separately and not included in the price bid.

1. Unless otherwise required, submit only one copy of the bid.
2. Bids, amendments thereto or withdrawal requests received after the time advertised for bid opening will be void regardless of when they are mailed.
3. Quote prices on units specified with packing included.
4. Attach complete specifications for any permitted substitutions offered, or when amplification is desirable or necessary.
5. If specifications or description papers are submitted with bids, enter bidder's name thereon.
6. If the article bid upon has a trade name or brand name, show same on the bid.
7. When required, furnish samples, free of expense, prior to the opening of bids. Label each sample with bidder's name and the item number. Should you wish samples returned, at your expense, when not destroyed in tests, make requests for return within 10 days following opening of bids.
8. Show delivery time required after order is received (see bid below).
9. Address and mark bids as indicated in the notice.

CONDITIONS

1. The City reserves the right to reject any and all bids and to waive all technicalities.
2. In case of default of contractor, the City reserves the right to purchase any and/or all items in default in open market, charging contractor with any excessive costs. **SHOULD SUCH CHARGE BE ASSESSED NO SUBSEQUENT BIDS OF THE DEFAULTING CONTRACTOR WILL BE CONSIDERED UNTIL THE ASSESSED CHARGE HAS BEEN SATISFIED.**
3. All materials and products offered must be guaranteed to meet the requirements of the specifications indicated, given, or referred to.
4. Prices bid must be based upon payments in thirty days. Discounts for payment in less than thirty days will not be considered in making award.
5. The right is reserved in case tie bids are received to make award as considered to be most advantageous to the City.
6. The right is reserved to reject any bid in which the delivery time indicated is considered sufficient to delay the operation for which the commodity is intended.
7. Unless otherwise indicated, prices must be firm.
